Greetings Southern Foothills Area,

The RCM team attended the Carolina Region Service Committee Fort Mill on Saturday, July 9th. We had consensus on one proposal that was brought to us at the CRSC. It was a change in policy regarding the Regional Agenda Cycle or RAC. The RAC is basically a planning tool to help the region with guiding decision making, establish and align our resources with our priorities and evaluate progress towards our goals. A copy of the proposal will be included in next month's minutes.

We were the only area in the region to not approve the budget. In response to our areas concern that "the budget is twice as much as was actually used", the Office and Finance committee provided the following insight"

"The main reason the budget is larger than used is that the Region must provide by law the same basic amounts (mail, Gas, meals, etc) to every budgeted subcommittee in the CRSC - this is where the majority of the monies are allocated. Also, the budgets for the subcommittees are never met. Many do not turn in receipts (most folks see this as a donation for their services and gladly incur the costs themselves), so it looks like the money is not needed. But if someone were to turn in receipts, the funds would be available. This is why the funds are there so everyone regardless of personal financial situation can participate in Regional service."

The next Carolina Region Subcommittee Service Day is September 10, 2011. The previous one in May was poorly attended with three area representatives in H&I and four in PR. Both subcommittees are asked for some more support from the areas in September. Times and location will be announced next month or check out the events page at crna.org.

The First Annual Carolina Region Fellowship Assembly is scheduled for August 19, 20 and 21st, 2011 in Fort Mill, SC. Attached to the minutes is a flyer with details. On Saturday morning during the event, there's a 10:00 am workshop called "Roles and Responsibility: Facilitation and How to be an effective GSR/RCM/RD." We encourage all GSR's to attend. There is no charge for the event.

If anyone has any announcements, comments, questions or concerns they'd like discussed at the next CRSC in Fort Mill, please us know.

Homegroup members— The Southern Foothills Area of NA Area Service Committee needs you! There are positions that need to be filled in August.

What is the SFANA ASC, you might ask? The **Area Service Committee** is the primary means by which the services of our NA community are administered. The ASC directly supports your home group in "carrying the message." The area committee is composed of group service representatives (GSR's) and the administrative officers listed below:

 2011 SFANA ASC Open Positions <i>(in bold)</i> 
Chairperson -(Position Filled) The area committee chairperson is responsible for conducting committee meetings, preparing the agenda, and various administrative duties.
Co-Chair- (Vacant 8/21/2011) The primary responsibility of the area committee vice chairperson is the coordination of the area subcommittees and assisting chairperson with meetings.
Regional Committee Member-(Position Filled) RCMs keep their areas in touch with the larger world of NA.
RCM- Alt.- (Vacant 8/21/2011) Helps the RCM communicate between the homegroups and the rest of NA
Treasurer- (Position Filled) The treasurer receives contributions from the groups, administers the area's checking account, pays rent, reimburses budgeted expenses & keeps careful records of all transactions.
Alt. Treasurer- (There is willingness to fill this position) The Alternate treasurer assists the treasurer.
Activities Chair- (Vacant Oct. 2011) Helps subcommittee members plan and coordinate activities for the Area. Various positions are also available within the Activities Subcommittee.
H&I Chair- (Vacant 8/21/2011) Hospitals and institutions subcommittees conduct panels that carry the NA message to addicts who often have no other way of hearing our message. The H&I chair interacts with the facilities, the H&I Coordinators (who are needed also) and the H&I Panel Members.
PR Chair- (There is willingness to fill this position) The mission PR is to inform addicts and others in the community of the availability of recovery in NA. The PR Chair helps coordinate the actions of PR.
Secretary- (Vacant 8/21/2011) Area secretaries handle much of the ASC's paperwork. Their first responsibility is to take clear, accurate minutes of area committee meetings and distribute those minutes to all committee participants within a reasonable period of time after each meeting.
Alt. Secretary- (Currently Vacant) The Alternate Secretary assists the Secretary in their duties.
P&P Chair- (Currently Vacant) The P&P chair monitors SFANA policy, among other duties.

There is only one requirement for NA membership, "a desire to stop using," but there are many benefits. One of these benefits is the privilege of service. We who have the disease of addiction spent years of our lives locked up in ourselves. We were cut off from the warmth and fellowship of other human beings; our lives revolved almost exclusively around "getting and using and finding ways and means to get more." The love that connects one person to another to the next, the selfless service that warms and nurtures humankind—of that love, of that selfless service we had no part. That's why it's such a privilege in our recovery to be able to serve others, for we come to know ourselves only in looking beyond ourselves and we keep what we have only by giving it away. By empathizing with other members, by learning to appreciate their needs, by placing them ahead of our own—by these things we learn to love others, and in so doing we learn to love ourselves. *Source: The NA Guide to Local Services*
